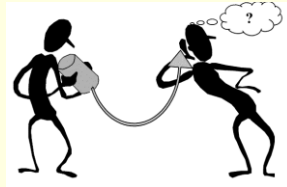
- local authorities
 - local self-administration:
 - no guidelines on a federal or state level possible
 - obligatory case review by law
- federal government and legislation
 - law: Youth Welfare Act
 - goals and tasks stated by law?
 - involving only youth welfare system
 - link from local to federal level
 - pilot projects
- state government and legislation
 - law: School Act, Health System
 - practice development

Data Protection – Confidentiality

- Flow of Information
 - providing data to the case reviewers (data transmission)
 - collecting data by the case reviewers



- Prosecution
 - right of refusal to give evidence for the case reviewers?

Data Protection – Confidentiality

Duty to Report/Notify

- Reporting to administrative body responsible for child protection (n=27)
mandatory for

all	professionals	nobody

- all States that have no duty to make reference are in the group of the prevention including States

Data Protection - Confidentiality

Mandatory Reporting

- to police/criminal justice system
mandatory for (n=24)

all	professionals	child protection service	nobody
2: PL, SK	4: CY, EL, LV, MT	8: BG, CZ, EE, ES, FR*, IT, LT**, RO * only felonies ** sexual assault, severe damage to health	10: AT*, BE, DE, DK, FI*, HU, IE, LUX, NL, SI, UK * mandatory if not overruled by needs of confidentiality

- mandatory reporting to police/criminal justice system only in underdeveloped countries

Prosecution

- give evidence in criminal proceedings
 - refusal to give evidence (§ 53 StGB)
 - no such right for case reviewers
 - involving of family members does not solve the legislative lack of protected confidentiality
 - precondition for more or less binding implementation of a case review system



- serious good case review must not be doing the work for the prosecutors/investigators and other law enforcement agencies

Data Transmission

- **Authorisation** to provide Data to the Case Reviewers
 - for reasons of research or planning (§ 75 SGB X)?
 - case review as scientific research on social service policy? (wissenschaftliche Forschung im Sozialleistungsbereich)
 - case review as social service policy planning by a public body? (Planung im Sozialleistungsbereich durch eine öffentliche Stelle)

Data Transmission

- § 75 SGB X as authorisation after legislation amendment
 - ... if yes:
 - permit by the federal or state ministry (Genehmigung durch die oberste Bundes- oder Landesbehörde)
 - anonymisation and/or pseudonymisation?
– How realistic is this?



Data Collection

- Authorisation (§ 67a SGB X)
 - public body or a private body who examines an organisation
 - allowed for the purpose of fulfilling a duty or task of the collecting body

- duties and tasks of the case reviewing bodies should/must be defined by law
- duty to initiate (and fund) „serious good case reviews“?
